# Kuskitannee Lodge Events<sup>1</sup>

#### **Lodge Banquet**

This event is hosted in January but the venue changes each year. The annual Lodge Banquet is open to all members and their friends/family. This event is a great time to come together to recognize our membership and new award recipients.

#### Winter Fellowship

Winter Fellowship is an event hosted at Camp Agawam or Camp Bucoco, usually in February. This event is primarily a fun "indoor" weekend. Each morning there is a made-to-order breakfast and during the day there are an abundance of fun activities and games centered around a particular theme. During this weekend, service is available for those Arrowmen who are interested. This event is also a fantastic time to take your Brotherhood Test! Vigil nominations will also occur during this event. Full of fun and fellowship!

#### Spring Ordeal

This event is in May at Camp Bucoco or Camp Agawam. This is the first chance for Ordeal Candidates to come out and become members; Brotherhood testing is also available. There are plenty of service opportunities for all members and theme centered activities are planned for the evenings! Vigil call outs also take place over the duration of the weekend.

#### **Big Three Weekend**

A weekend at Camp Bucoco or Camp Agawam in August where we induct Ordeal, Brotherhood, and Vigil Candidates all at the same time, "the Big 3"! Not only do we have service opportunities but Arrowmen who would like to become more involved in the Lodge can run for Executive Committee positions this weekend. It is another weekend centered around a theme that is full of fun and fellowship!

#### Lodge Leadership Development (LLD)

This is an event hosted at Camp Bucoco or Camp Agawam, usually in September. During the event, Lodge wide training cells take place to prepare the newly elected Executive Committee (EC) Members for their upcoming term. All members are welcome, but required for all EC members. Descriptions of positions are in Kuskitannee Lodge Manual of Administration

#### **Brookie Brotherhood**

This weekend is for brothers of <u>all honors</u>. Usually November at Camp Agawam or Camp Bucoco, this weekend is an excellent time for Ordeal Members to seal their membership in the Order of the Arrow. This weekend has service opportunities and activities based on a theme. During this weekend, Silver Chief and Founder's Award nominations and voting take place. It is packed full of fun and fellowship for everyone.

#### Service Days

This is an event that takes place at both Camp Bucoco and Camp Agawam. This event is held all year around. This is a great way to get your service for Awards and a great way to give back to camp. Everyone is welcome at this event, even if you are not in the lodge.

# **Section Events**

#### **NE-4B Conclave**

Conclave is an event often in June where all of the Lodges within our Section have the opportunity to meet and have a ton of fun. #### Section Advancement of Lodge Leader's Summit (SALLS)

SALLS is a training program run by the Sections for the Lodge EC (LEC) of all 4 Lodges in the Section. Its intention is to collaborate on weaknesses brought by Lodge Chiefs and to bring change about those weaknesses. It is also a great way to grow and learn.

## **National Events**

#### **National Order of the Arrow Conference (NOAC)**

At each national conference, Arrowmen come together from around the world to share ideas, learn from one another, and most importantly experience an outstanding conference that is unlike any other event in Scouting. NOAC seeks for the best that the Order has to offer and it is only open to members of the OA! NOACs are held every two years, with exceptions made to align the event with significant anniversaries.

#### National Leadership Seminar (NLS)

NLS is a weekend conference that is intended primarily to enhance the leadership skills of the Order of the Arrow's key youth and adult members. NLS prepares Arrowmen to become better leaders both within and outside of the Scouting program. You can sign up by expressing interest to the Lodge Advisor or Lodge Chief.

#### Order of the Arrow High Adventure (OAHA)

Through OAHA (Order of the Arrow High Adventure) you get to spend TWO weeks on the National Adventure Base of your choice. You can attend Florida Sea Base, Northern Tier, Philmont Scout Ranch or the Summit as an Arrowman alongside other Arrowmen. Ask your Section Officer about the section scholarships that are available! # **History of Kuskitannee Lodge #168**

When Pioneer Trails Council and Lawrence County Council consolidated in 1973 to form Moraine Trails Council, it appears that there was much dissent to the merger. The two Lodges, Unalachtigo 168 and Packanke 419 continued to operate independently throughout most of 1973 which explains why there are chiefs listed for both Unalachtigo and Packanke. Unalachtigo's final event appears to have been the 1973 Area III-F meeting in September of 1973. Packanke's final event appears to have been the Area III-B meeting in August of 1973. As of this writing, this author has been unable to locate any record of activity of Kuskitannee 168 until the spring of 1973.

The Lodge name selected for the new Lodge was Kuskitannee Lodge #168, W.W.W. The name was derived by using Kusk from the Kuskuskiees, and Kittany, the name of the trail which stretched across Butler County from New Castle to Kittanning and also the name of a village on the Allegheny river. The totem selected was the Brook Trout which inhabited Slippery Rock Creek, which bound the two council camps, Agawam and Bucoco. The Lodge neckerchief and pocket flap naturally bear this totem. A Lodge fighting song was adopted. Special T-shirts and jackets were also soon available and caps given to active working Arrowmen of the Lodge bore the insignia.

Kuskitannee's first chief was Bill Wilson of New Castle. The lay advisor was Harry Wright also of that city. Professional advisor was Bruce D. McElroy, program director of the council. As of this writing, this is in dispute as two other names are listed as first advisor of Kuskitannee: Ole Hunter and Clyde Braun.

The new Lodge went to DuBois, Pa., Camp Mountain Run, to the final Area III-B Conclave Aug. 17-19, 1973. (ed. The 1973 III-B Meeting program booklet states that Packanke Lodge 419, Moraine Trails Council would cease to exist at the end of this event) After that, National realigned and Kuskitannee became part of Northeast Section 5-C.

In 1975, Kuskitannee Lodge hosted the Section 5-C Conclave at Westminster College, New Wilmington, Lawrence County, with the young Lodge's officers getting into the "thick of the action". It was thought the college would give the section meeting a new atmosphere.

In 1983, Lodge #168 hosted the 5-C Conclave at Camp Bucoco as the policy shifted again. More than 300 Arrowmen attended that meeting.

Kuskitannee with its traditions of two fine Lodges behind it continued to offer leadership at the Area level. It grew stronger and in 1977 adopted new by-laws to keep up with national OA changes.

In the early 1980s, Glacier Ridge District senior executive Vincent Dunn, who joined the council in 1979, became the Lodge's staff advisor. Under his tutelage, Lodge 168 earned four E. Urner Goodman Camping Awards for its excellence. Dunn pushed the Lodge hard and helped to weld it into one of the finest in the nation. He retired and left the council after the June, 1991, conclave which was hosted at Camp Bucoco.

A special patch was designed to mark the tenth year of the Lodge and more activities were scheduled. Now there would be the Fellowship winter weekend, the Spring Ordeal, the Big Three, after camp closed, and the annual Father-Son dinner. Special awards, like a hat, and pins would be given to members who attended the four most important yearly events. In '90, at the recognition dinner three members received their 11th pin for 11 years of full participation.

By 1988, Kuskitannee had hosted 5-C Section Conclave and furnished at least three Section Chiefs. George Andrews, was elected Lodge chief, then became Section Chief, then later was Northeast Region Chief. Tony Sbarra, Jr., in 1983, and Thom Gaiser were also section chiefs. Other Lodge members have been secretary or held other posts.

In 1984, the Lodge erected the beautiful metal lettered sign at the entrance to Camp Bucoco on Route 8 north of Butler.

Bill Graham, first Lodge chief of Unalachtigo, estimated in 1989 that between 4,500 and 5,000 youth and men had become members of the Lodge from 1939 as the Lodge marked its 50th anniversary July 22, 1989, at Bucoco.

When Kuskitannee 168 became official on January 2, 1973, officers to help Bill Wilson, chief, were: Ron Badger, also of New Castle, vice chief; Dave Bock, secretary, and Tony Lucas, treasurer, also of New Castle. W. A. Waggett, council program director, was the professional advisor, and lay advisors were Ole Hunter, and William Clark, associate. Harold Ramsey of New Castle, designed the Brook Trout blue patch.

The new Lodge was ready for action at both Bucoco and Agawam. About 30 members attended the final III-F Conclave at California State College of PA, hosted by Kiasutha #57, Allegheny Trails Council. Neal Bronder, Lodge 168, was the last area chief for Area III-F.

In June, 2008, Kuskitannee was moved from section NE-4B to the new section NE-4A

In service, Lodge 168 has contributed to both Camp Bucoco and Camp Agawam. Such projects have included erecting a brand new sign for Camp Bucoco in 1984 and are responsible for many roofing projects. These projects could not have gone underway without the help of many of Kuskitannee's Lodge chiefs.

In 2010, Kuskitannee Lodge received a National Service Grant from OA National for \$2500. The Lodge added \$5000 to this to install lightning detection and warning systems at both Camp Agawam and Camp Bucoco.

# **History of Rae's Cabin**

Rae's Cabin: Kuskitannee Lodge has a building dedicated to the exclusive use of the Lodge. It is located across the parking lot from the trading post at Camp Bucoco. It was built to honor the

memory of Rae Creasy, one of our youth members who passed away at the age of 14 from Cystic Fibrosis.

Rae W. Creasy was born July 1, 1984. When he was old enough, he became a Cub Scout and then a member of a short lived Boy Scout Troop, Troop 743, in Neshannock Twp. (New Castle, PA). He joined Troop 733 in New Wilmington and was soon elected to membership in the Order of the Arrow and took his Ordeal in August 1996 at just a bit over 12 years of age.

He became a brotherhood member of Lodge 168 in August 1997. He served the Lodge as a member of the Lodge Executive Committee. He was Service Chairman, and Chairman of the Brotherhood and Elangomat Committees, and also served on the Dance Team where he was a traditional dancer and hoop dancer. There is a picture of him, in uniform, on the wall of Rae's Cabin. The Boy Scouts and especially the Order of the Arrow were his favorite activities.

From birth, Rae suffered from a nasty disease called Cystic Fibrosis which affects the digestive system and respiratory system. His typical breakfast was a bowl full of pills.

Rae never complained about his problems. He never did anything physical fast; always slow and deliberate. He would do a 30 minute dance show then go home and sleep for two days to recover.

He was reviewed and recommended for the rank of Eagle on September 29, 1998. In late October 1998 he developed pneumonia. On the evening of November 4, 1998 his Eagle badge was pinned on to his hospital gown while he was comatose in Childrens' hospital in Pittsburgh. His mother swears there were tears in his eyes. Twelve hours later, at 7:30 AM on November 5, 1998, he went home to be with the Creator. His body simply was not strong enough to fight the pneumonia. He was just 14 years old.

His family wanted to do something in his memory for his favorite group. Rae's Cabin is that something and Kuskitannee Lodge 168 is that group. He loved the Boy Scouts but he really loved the OA and his fellow Arrowman brothers.

The gift was announced at the Lodge banquet in February 1999. Ground was broken in March 1999 and the building was dedicated in August 1999. That is a truly ambitious timeframe for any building, but even more so when you realize two things;

- 1) The family donated funds for all the materials. And,
- 2) The labor was 100 percent volunteer. Not one penny was spent on labor. Rae's family, friends, troop, fellow Arrowmen, neighbors and more than a few people that never even met Rae, showed up to help. Every weekend from March through August there were anywhere from 3 to 70 people at Camp Bucoco working on what was to become Rae's Cabin.

This building is dedicated to the exclusive use of Kuskitannee Lodge. Lodge executive committee meetings, dance team practice, ceremony team practice and other Lodge specific activities are held there. Only good thoughts, good actions, good things take place there. There is a lot of fun, a lot of laughter and a lot of important work done in Rae's cabin.

# **Awards<sup>2</sup>**

<u>Silver Chief Award:</u> This award is eligible to be given annually to two Lodge members, one youth and one adult, who have rendered noteworthy service of exceptional quality to the Lodge. This is the highest award given by the Lodge.

**Founder's Award:** This award is eligible to be given to one youth and one adult per year. This is a National Award recognizing those who have rendered exemplary service to the Lodge and Order. The selection process will follow current National Policy for selection of candidates for this award along with our Lodge bylaws.

**Spirit of Service (SOS)**: This award is given to those members who give over 50 hours of volunteer service to the council and camps of Moraine Trails Council in a given calendar year.

**168 Award:** This award is given to those members who donate 168 hours or more of their time to service to the council and camps of Moraine Trails Council in a given calendar year.

<u>Participation Award:</u> This award fills the requirements of 4 categories to better the Lodge, ceremonies, dance team, and activities of the Lodge. This award can only be earned once in a lifetime.

<u>Training Trout:</u> In this award, In an effort to promote training in all levels of Scouting, Kuskitannee Lodge has initiated this award. The Training Trout award is given to Lodge members who participate in a substantial amount of training over the course of a calendar year. To receive this award, 20 credits must be earned from the following categories: Troop, Lodge, Conducting, and National. This award can only be earned once in a lifetime.

<u>Distinguished Elangomat Award:</u> This award is designed to distinguish elangomats who go above and beyond what is expected of them. For this award, you must serve as an elangomat, stay in touch with your clan, and help your clan become Brotherhood, and a few more requirements. This can only be awarded once in a lifetime.

Kuskitannee Troop Camping Award: This award was designed to distinguish Troops who are active within our Lodge. Some of the requirements are to attend summer camp, hold 12 or more troop outings, and attend at least 4 EC Meetings, and a few more.

# What is an Elangomat?

In the language of the Lenape, Elangomat literally means "friend". The Elangomat is the Brother in the Lodge that served with you throughout the course of your Ordeal. He or she was already a member of the Lodge and chose to go through the Ordeal a second time so that they could help people like you to join the Order and pass through your Ordeal without flinching. The Elangomat was your friend through your trials and tribulations during your Ordeal, and they will remain with you through your journey ahead to Brotherhood as long as you choose to stay.

To be an Elangomat is a rewarding and challenging experience. As the Elangomat you go through the tests of the Ordeal along with the candidates. Your example is a better teacher of Brotherhood, Cheerfulness and Service than any spoken words. By learning more about the Order and yourself, you also rededicate yourself to the Order. If you are interested in being an Elangomat you must simply approach the Ordeal Master and ask to become one. This is not a contract that says you must be an Elangomat forever, but just that one event. It is an honor to become an Elangomat, not a punishment, and should be treated as such.

Each Elangomat generally leads a patrol size group of candidates, often called a "clan". When the Lodge uses them, each clan is independent from the others. Since an Elangomat shares the test of silence and cannot easily ask questions, the Lodge trains him in advance. During the Ordeal the Lodge provides him with close support to meet any needs.

Your Elangomat was a friend to you when you joined our Order. Be a friend to another and help them to be welcomed into the Order of the Arrow!

## **The Challenges of Brotherhood Membership**

Brotherhood membership in the Order of the Arrow is not a rank or step up the ladder in the same sense as from First Class to Star, Life, or Eagle Scout.

Brotherhood membership is the completion of the process of becoming a true Arrowman. Brotherhood members have no special privileges that are not open to Ordeal members, except to attend Brotherhood ceremonies. They do, however, have additional responsibilities and obligations.

You must meet five challenges before you can enter the Circle of the Brotherhood. The first of them you should meet now. The next three require steady effort over a period of months. The last challenge you must meet after you are satisfied you have met the first four.

- 1. **Memorize the signs of the Order of the Arrow.** Memorize the Obligation of the Order, the song of the Order, the admonition, the sign of Ordeal, and the handclasp. Also, be familiar with the ceremony. This information will be in a letter you receive once you are eligible to receive your Brotherhood Honor.
- 2. Advance in your understanding of the Ordeal. Gain thorough understanding of the Ordeal.
- 3. **Serve your Unit.** Remain registered in Scouting. <u>During a period of six (6) months</u>, strive to fulfill your Obligation by expanding your service to your troop.
- 4. **Plan for service in your Lodge.** Retain your registration in
- 5. the Lodge and keep your dues paid. Beware that acceptance of Brotherhood involves a pledge of service.
- 6. Review your service. When you earnestly feel that you have met the four challenges above, write a letter to the Brotherhood Chairman. In this letter explain the following:
  - a. What do you think the Ordeal means?
  - b. Describe how you have been fulfilling this Obligation in your troop and daily life, and how you have used this understanding of the Ordeal to aid in this service.
  - c. Describe your future Lodge plans.

  - a. You were led by Kichkinet to the North end of camp where the significance of the arrow was first revealed as you tested the bow.

I will always regard the ties of Brotherhood in the Order of the Arrow as lasting, and will seek to preserve a cheerful spirit, even in the midst of irksome tasks and weighty responsibilities, and will endeavor, so far as in my power lies, to be unselfish in the service and devotion to the welfare of others.

  - a. The Arrow whose undeviating course, when aimed high, is a token of leadership.

  - a. Pointed over the right shoulder.

## **Vigil Honor**

Alertness to the needs of others is the mark of the Vigil Honor. It calls for an individual with an unusual awareness of the possibilities within each situation.

The Vigil Honor is a high mark of distinction and recognition reserved for those Arrowmen who, by reason of exceptional service, personal effort, and unselfish interest, have made distinguished contributions beyond the immediate responsibilities of their positions or office to one or more of the following: their Lodge, the Order of the Arrow, Scouting, or their Scout camp. Under no circumstances tenure in Scouting or the Order of the Arrow is considered as reason enough for a Vigil Honor recommendation.

The Vigil Honor is the highest honor that the Order of the Arrow can bestow upon its members for service to Lodge, council, and Scouting. It dates from the year 1915, when founder E. Urner Goodman became the first Vigil Honor member. Since then, thousands of members have received the Vigil Honor.

Vigil Honor members have an honorable tradition to uphold. They must at all-time conduct themselves in accordance with the ideals of Scouting, the Order of the Arrow, and the Vigil Honor. Membership cannot be won by a persons' conscious endeavor. It comes as a recognition of unselfish leadership in service. This fact should be given careful consideration in the selection of candidates for membership. The Vigil Honor has successfully fulfilled a definite and satisfactory service to the Order of the Arrow, to Scouting, and to individual members. Its continued success depends on the care with which future members are selected and on the maintenance by its members of the high ideals of service to others for which the Vigil Honor has always been known.

Any member of the Order of the Arrow registered in Scouting in good standing in a regularly chartered Lodge, is eligible for recommendation to the national Order of the Arrow Committee for evaluation to thee Vigil Honor, provided that, at the time of recommendation, the individual has been a Brotherhood member for a minimum of two years. Because the Order of the Arrow is primarily an organization for youth, it is suggested that, in recommending candidates for the Vigil Honor, preference is given to those who were inducted into the Order as Scouts, rather than those who were inducted into the Ordeal as adult volunteers or professional Scouters.

Members of the Order can be inducted into the Vigil Honor only with the written approval of the National Order of the Arrow Committee.





- 4. Runs all Executive Committee Meetings
- 5. Directs and assist other Executive Committee members to achieve a mutual goal
- 6. Must follow all of the set by-laws and National Order of the Arrow rules

#### **Executive Vice-Chief**

- 1. Reports regularly to the Lodge Chief
- 2. Attends all Executive Committee Meetings and Lodge Events
- 3. Holds full responsibility of the Lodge and all of its operations in the absence of the Lodge Chief
- 4. Runs all Executive Committee Meetings in the absence of the Lodge Chief
- 5. Directs and assist other Executive Committee members to achieve a mutual goal
- 6. Must follow all of the set by-laws and National Order of the Arrow rules
- 7. All other duties assigned by the Lodge Chief

#### **Lodge Secretary:**

- 1. Takes minutes at all EC Meetings.
- 2. Provides an electronic copy of each meeting's minutes to Lodge Chief, Lodge Advisor, Executive Vice Chief and Publications Chair (via email) within 48 hours after the close of a meeting.
- 3. With the Admin Vice-Chief, helps manage the registration associated with all Lodge events.
- 4. Keep all Lodge documents current and organized.
- 5. Brings enough physical copies of the previous meetings minutes and current agenda for each chairman to every LEC meeting.
- 6. All other duties assigned by the Lodge Chief

#### **Lodge Vice-chief for Membership:**

1. Reports to the Lodge Chief.

- Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Responsible for the following committees: Brotherhood, Elangomat, Elections, and Vigil Honor.
- 5. Serves as chair of the membership committee; and along with the Lodge Adviser for membership and the Lodge Chief, manages the membership and dues function of the Lodge.
- 6. Provides Lodge officers and committees with unit contact information needed for unit elections, camping promotions and other approved functions.
- 7. Maintains the history of the Lodge.
- 8. Any other duties assigned to him by the Lodge chief

#### **Lodge Vice-Chief for Administration:**

- 1. Reports to the Lodge Chief.
- 2. Prepares a **detailed** Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Responsible for the following committees: Publications, Web Page and Trading Post.
- 5. Contacting the committee chairmen on a regular basis, meeting with them before or during an event and reporting to the chief on a monthly basis what is being planned and performed.
- 6. Provides direct leadership for the execution of Lodge Weekends:
  - a. Is promotion in place @ -45 days before the event? (Follow Up with Communications)
  - b. Develop the weekend program at the LEC Meeting prior to the event?
  - c. Is the menu prepared @ -30 days before the event? (Follow Up with Activities Committee)
  - d. Are faith-based services established and confirmed @ -30 days? (Follow Up with Activities Committee)
  - e. Is a Health Officer recruited and confirmed @ -14 days (Follow Up with the Activities Committee)
  - f. Is the Weekend Program established and in print? Do all participants know their roles? (Personal contact with each team involved.) @ -14 days
  - g. Registration set and communicated to secretary @ -7 days
  - h. Meal count to cook @ -7 days
  - i. Call & Confirm all plans with the Camp Ranger @ -7 days
  - j. Be present at the registration area and be the "on-site" point person for the administration of the event weekend. Make sure to be able to direct the Lodge and participants in the administration of clan formation; Elangomat assignment; and Pre-Ordeal Ceremonies. You (and your Advisor) are the "go-to" people with all the answers and the ability to make sure that the weekend is off and running smoothly.
- 7. Any other duties assigned to him by the Lodge Chief.

#### **Lodge Vice-chief for Program:**

- 1. Reports regularly to the Lodge Chief.
- 2. Prepares a **detailed** Committee Report about all committee functions to be presented at LEC Meetings.

- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Responsible for the following committees: Activities, Dance Team, Service, Conclave, Camp Promotion and NOAC.
- 5. Creates a detailed schedule for each Lodge weekend
- 6. Communicates regularly to ensure activities and events are scheduled and planned
- 7. Contacting the committee chairmen on a regular basis, meeting with them before or during an event and reporting to the chief on a regular basis what is being planned and performed.
- 8. Along with the Lodge Chief, designs the Lodge program for the year and ensures that the plan is carried out.
- 9. Any other duties assigned to him by the Lodge Chief.

#### **Publication Committee Chairman:**

- 1. Regularly reports to the Administration Vice-Chief.
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. Recruits members for the committee and chairs the committee meetings and functions.
- 4. Collect articles describing past and upcoming events from every committee chairman and officer as needed.
- 5. Edits and publishes a Lodge newsletter called Kuskita on a regular basis with help from the Vice Chief of Administration.
- 6. Any other duties assigned to him by the Lodge Chief.

#### **Trading Post Committee Chairman:**

- 1. Regularly reports to the Administration Vice-Chief.
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Takes inventory of all Lodge merchandise on a regular basis.
- 6. Displays and sells Lodge merchandise at all Lodge events, and keeps records as directed by the advisor.
- 7. Plans for new Lodge merchandise that will promote the Lodge and the Order; and submits plans to the Lodge chief as needed.
- 8. Assists with special fundraisers as needed.
- 9. Plans for summer camp and coordinates the transfer of inventory to the camp trading post when needed.
- 10. If desired, maintain a stock of items at the council Scout Shop.
- 11. Any other duties assigned to him by the Lodge Chief.

#### **Vigil Honor Selection Chairman:**

- 1. Regularly reports to the Membership Vice-Chief.
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Plans and coordinates the annual selection of Vigil Honor recipients at the Spring Ordeal.

- 6. With the Lodge adviser and Vigil Honor advisor, prepares all paperwork when needed for the selection and helps prepare the paperwork for National.
- 7. Performs all Vigil Honor ceremonies
- 8. Coordinates a recognition ceremony.
- 9. Any other duties assigned to him by the Lodge Chief.

#### **Camp Promotions Committee Chair:**

- 1. Regularly reports to the Program Vice-Chief
- Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Works to create a promotional brochure to be distributed at unit elections
- 6. Promotes the council's camping programs throughout the three districts. This includes attending roundtable meetings, unit meetings and district camporees when necessary.
- 7. Promotes High Adventure opportunities to all youth within the council.
- 8. Works with the District vice-chiefs to schedule camp promotions with the unit elections.
- 9. Any other duties assigned to him by the Lodge Chief.

#### **Brotherhood Committee Chairman:**

- 1. Regularly reports to the Membership Vice-Chief
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Communicates regularly with a Lodge Master System Administrator to remain aware of possible Brotherhood Candidates.
- 6. Coordinates a brotherhood team to perform brotherhood testing at Lodge events.
- 7. Contacts all eligible brotherhood candidates before an event.
- 8. Shall assist the Ceremonies committee with carrying out the brotherhood ceremony.
- 9. Any other duties assigned to him by the Lodge Chief.

#### **Ordeal Master/Head Elangomat:**

- 1. Regularly reports to the Membership Vice-Chief
- Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Shall contact the Ordeal Candidates prior to their ordeal and provide them with the necessary information about the Ordeal (dates, equipment to bring, costs, etc.)

- 6. Recruits Elangomats for the Ordeal weekend and trains them accordingly, especially in regards to the induction principles of the Order of the Arrow.
- 7. Coordinates the team of Elangomats that shall lead the Ordeal Candidates throughout their Ordeal weekend.
- 8. Assigns work projects with the assistance of the service chairman to the Elangomats for their clans to carry out during the Ordeal.
- 9. Promotes communication between the Elangomats and their clan members until the new members achieve Brotherhood.
- 10. Any other duties assigned to him by the Lodge Chief.

#### **Activities Committee Chairman:**

- 1. Regularly reports to the Lodge vice-chief for the program.
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Along with the Program Vice-Chief, plans the annual Lodge recognition dinner.
- 6. Plans games and activities for all Lodge weekends.
- 7. Coordinates with the summer camp staff and plans for OA fellowship time during summer camp.
- 8. Any other duties assigned to him by the Lodge Chief.

#### **Dance/Drum Team Committee Chairman:**

- 1. Regularly reports to the Program Vice-Chief
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Plans and coordinates a dance team, which will perform Native American Dances at council events, summer camp and other events in which the team would perform.
- 6. Plans and schedules regular Dance/Drum Team practices.

- 7. Along with the Ceremonies Committee, searches for new equipment for the ceremonies team and shall purchase such equipment using Lodge funds with approval of the Lodge executive committee using money available in the Lodge budget.
- 8. Any other duties assigned to him by the Lodge Chief.

#### **Service Committee Chairman:**

- 1. Regularly reports to the Program Vice-Chief.
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Coordinates with the Camp Ranger or Caretaker to select work projects to be done by the Lodge for Camp Bucoco or Camp Agawam prior to any Lodge weekend.
- 6. Runs point on the service segment of Lodge Weekends, ensuring all crews have proper tools, instructions, water, ect.
- 7. Organizes special workdays for the Lodge with the approval of the Executive Committee and shall publish the dates in the Kuskita.
- 8. Promotes service opportunities available to Arrowmen and Boy Scout Troops.
- 9. Any other duties assigned to him by the Lodge Chief.

#### **Elections Committee Chairman:**

- 1. Regularly reports to the Lodge Chief.
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Responsible for coordination of the troop representative program, unit elections and camp promotions.
- 5. Manage all unit elections as needed, contacting each Scoutmaster in his to schedule an election, performing elections by national procedures and coordinating election teams within the districts.

- 6. Promotes the troop representative program and communicates regularly with troop representatives in his district; and also maintains a current list of all troops and the OA representative for each unit.
- 7. Keeps in communication with all OA Troop Guides throughout the duration of his term
- 8. Attends district roundtable meetings or sends a replacement when necessary.
- 9. Any other duties assigned to him by the Lodge Chief.

#### **Ceremonies Committee Chairman:**

- 1. Regularly reports to the Membership Vice Chief
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Coordinates a ceremonial team to conduct all ceremonies throughout the Lodge, which include Ordeal and Brotherhood.
- 6. Coordinates all call-out ceremonies; and shall supervise any revisions to the currently published call-out ceremony and also seek approval of the summer camp director for the ceremonies at camp.
- 7. Ensures all ceremonies run smoothly and on-time.
- 8. Plans the practices of the ceremonies team and contacts all ceremonies team members accordingly.
- 9. Coordinates the cleaning of the circle and the trails that are used by the Lodge for ceremonial purposes.
- 10. Along with the Drum/Dance Team, searches for new equipment for the ceremonies team and shall purchase such equipment using Lodge funds with approval of the Lodge executive committee using money available in the Lodge budget.
- 11. Any other duties assigned to him by the Lodge Chief.

#### **Conclave Chairman:**

- 1. Reports regularly to the Program Vice Chief
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Promotes the section conclave and encourages Lodge members to attend the event.
- 6. Plans and coordinates all events the Lodge is responsible for during a section conclave. (Shows)
- 7. Attends all Council of Chiefs meetings with the Lodge Chief or designated representative.
- 8. Remains in contact with the Host Lodge for any updates regarding conclave.
- 9. Any other duties assigned to him by the Lodge Chief

#### **Technology Coordinator:**

- 1. Regularly reports to the Administrative Vice Chief.
- 2. Prepares a detailed Committee Report about all committee functions to be presented at LEC Meetings.
- 3. When asked, write an article about a subject relevant to the committee for the Kuskita and send it to the Publications Chair in a timely fashion.
- 4. Recruits members for the committee and chairs the committee meetings and functions.
- 5. Maintains a current Lodge webpage within the standards of the Boy Scouts of America and approved by the Lodge adviser and council webmaster.
- 6. Assists the publications chair and publishes the Kuskita, at least in part, on the internet
- 7. Posts on the Lodge Social Media Pages (Facebook, Twitter, Instagram and Snapchat)
- 8. Any other duties assigned to him by the Lodge Chief.

# **By-laws of Kuskitannee Lodge 168**

Last Revised on 11/18/12

**PREAMBLE:** We do hereby promise and adopt the following rules and regulations for the organization and operation of the Kuskitannee Lodge #168, Order of the Arrow W.W.W. (Wimachtendienk, Wingolauchsick, Witahemui), for the following purposes:

- 1. To recognize those campers (Scouts and Scouters) who best exemplify the Scout promise and law in their daily lives and by such recognition cause other campers to conduct themselves in such a manner as to warrant recognition.
- 2. To develop and maintain camping traditions and spirit.
- 3. To promote Scout camping, which reaches its greatest effectiveness as a part of the unit's camping program.
- 4. To help strengthen the district and council camping program both year-round and summer camp as directed by the camping committee of the council.
- 5. To crystalize the Scout habit of helpfulness into a life purpose of leadership in cheerful service to others.

#### ARTICLE ONE -- NAME AND AFFILIATION

- Sec. 1. The name of this Lodge in the Order of the Arrow, shall be Kuskitannee Lodge #168 W.W.W.
- Sec. 2. The Lodge is affiliated with Moraine Trails Council of the Boy Scouts of America and is under the administrative authority of the Scout Executive and the council camping committee.

#### ARTICLE TWO --TOTEM EMBLEM

- Sec. 1. The totem of the Lodge shall be the brook trout.
- Sec. 2. All items bearing the Lodge name or totem must be approved by the Lodge executive committee.

#### ARTICLE THREE -- MEMBERSHIP

- Sec. 1. Membership in the Lodge is open to currently registered members of Moraine Trails Council, B.S.A, on the basis of the latest printing of the Order of the Arrow Handbook.
- Sec. 2. Dues Annual dues will be required to register with the Lodge for a year and should be paid by December 15. Any member not paid by the Lodge Banquet will be removed from the roster of active members. The dues year will be from January 1 to December 31.

- Sec. 3. Election to membership -- Procedures for the election and induction of ordeal candidates will be in accordance with the latest printing of the Order of the Arrow Handbook.
  - Sub. Sec. 1. All unit elections must be cleared through the Lodge chief or his designee.
  - Sub. Sec. 2. Adult Scouters -- A letter of nomination must be submitted by the Scouter's unit, district, or council committee. Each nomination must be accompanied with full details as the reason for such recommendation and must be approved by the Scout Executive, Lodge Adviser, and Staff Adviser.
- Sec. 4. Transfers -- A member of the Order of the Arrow from another Lodge who is registered in the council may apply for transfer in the Lodge by presenting proof of membership in the former Lodge. The current year's dues will be required of all members wishing to transfer into the Lodge
- Sec. 5. Special Elections -- Adults registered in a council or district position who do not meet the camping requirements may be elected to the Lodge by the Scout Executive, Lodge Adviser, and Staff Adviser.
- Sec. 6. Inactive members may be restored to active membership by paying the current year's dues and a penalty established by the Lodge Executive Committee (ref Article 3 Sec 2).

#### ARTICLE FOUR -- CEREMONIAL HONORS

- Sec. 1. The only honors of the Lodge shall be those recognized by the National Order of the Arrow committee and are as follows: Ordeal Honor, Brotherhood Honor, and Vigil Honor. All members have equal status regardless of honor.
- Sec. 2. Attainment of the Brotherhood membership or the Vigil Honor shall be in accordance with the requirements in the latest printing of the Order of the Arrow Handbook.

#### ARTICLE FIVE -- OFFICERS

- Sec. 1. The permanent officers of the Lodge shall be the Supreme Chief of the Fire (Scout Executive or his designate) and the Camp Chief of the Fire (Summer Camp Director).
- Sec. 2. The elected officers shall be the Lodge chief, Lodge vice chief(s), Lodge secretary (ies) and the Lodge treasurer. They shall be elected in the order found in the manual of administration.
- Sec. 3. A training session for the Lodge officers and committee chairman shall be held at a time determined by the Lodge chief and the advisers.
- Sec. 4. All elected officers with the exception of those specifically designated by these by-laws and the national Order of the Arrow committee shall be youth members for their entire term of office.
- Sec. 5. The term of office shall be from swear-in to swear-in for the officer. Elections for officers may be held prior to the swear-in date.

Sec. 6. The appointed officers of the Lodge shall be the staff adviser, appointed by the scout executive, and the lay adviser(s), who shall be appointed for no more than one three year term, by the Scout Executive in consultation with the council camping committee. Committee chairmen, meeting the same eligibility requirements as the elected offers, shall be appointed by the Lodge chief after consulting with the Lodge adviser (Ref. Article 6 Sec. 3 Sub.2).

#### ARTICLE SIX -- ELECTION OF OFFICERS

- Sec. 1. The Lodge officers shall be elected annually. The date shall be established and announced by the executive committee at least 60 days prior to the election.
- Sec. 2. Only dues paid youth members shall be entitled to vote at the annual election or be eligible for any office.

#### Sec. 3. ELECTION PROCEDURES

- Sub. Sec. 1. An active member wishing to run for office(s) must make his intentions known to the Lodge chief or his designate in writing, care of the council service center, at least 30 days prior to the election.
- Sub. Sec. 2. After proper examination of his qualifications and the approval of the Scout Executive or his designate, his name shall be placed in nomination.
- Sub. Sec. 3. Election shall be by ballot. A slate of eligible candidates will be provided by Lodge chief or his designate. The ballots will be distributed, collected and counted by the Lodge Adviser or his designate.
- Sub. Sec. 4. If there is no candidate for a particular office, that office will be filled by an appointment made by the Lodge chief with the approval of the Lodge executive committee within thirty days. He must meet the same eligibility requirements as the other officers.
- Sec. 4. The Lodge shall have a manual of administration that specifies the duties of the Lodge officers, appointed chairman and adult advisers. The manual of administration may be revised by the Lodge chief, but must be approved by a majority vote of the elected Lodge officers and the Lodge staff adviser. The Lodge chief still retains the right to establish ad-hoc committees without revising the manual of administration provided that the committee exists no longer than four months.

#### ARTICLE SEVEN -- VACANCY OF OFFICE

Sec. 1. In the event of a vacancy in an elected office during the term of office, the office shall be filled as provided for in Article Six, Section 3, Sub Sec. 4, unless otherwise provided in these bylaws or the manual of administration.

#### ARTICLE EIGHT -- REMOVAL FROM OFFICE

- Sec. 1. Any officer who is not present at two consecutive executive committee and/or regularly scheduled meetings, without prior excuse from the Lodge chief or an adviser for sufficient cause, is considered to have resigned from office and the vacant office will be filled as provided for in these by-laws.
- Sec. 2. Any officer may be removed from office for failing to fulfill the duties of his office or for conduct unbecoming a Scout.
- Sec. 3. Notice of the executive committee's intended action must be served upon the officer charged in writing, informing him of the time and place of the intended action and of his right to be present to answer the allegations. He has no vote in this matter.
- Sec. 4. Any committee chairman who fails to fulfill his duties may be removed from the chairmanship by the chief after consultation with the Lodge adviser(s) or the Scout Executive.

#### ARTICLE NINE -- THE EXECUTIVE COMMITTEE

- Sec. 1. The executive committee of the Lodge shall be composed of the Lodge chief and all elected or appointed officers of the Lodge, the Lodge advisers and the Scout Executive or his designate.
- Sec. 2. A quorum shall consist of 5 voting members of the executive committee of which two must be elected officers and one Lodge adviser.
- Sec. 3. Only youth members of the executive committee shall have a vote in matters before the committee (under 21).
- Sec. 4. The Lodge Chief may only vote if it changes the outcome of a motion.
- Sec. 5. The executive committee shall hold at least four meetings a year and has the power to act in all matters between Lodge meetings.
- Sec. 6. Notice of any executive committee meeting must be given to all members of the executive committee.
- Sec. 7. The executive committee shall take no actions or establish any policies or procedures which are contradictory to that of Moraine Trails Council, the Order of the Arrow, of the Boy Scouts of America.

#### ARTICLE TEN -- LODGE MEETINGS

- Sec. 1. The Lodge's functions and activities shall be of a nature consistent with the high principals, purposes and aims of the Order of the Arrow and the Boy Scouts of America.
- Sec. 2. There shall be at least four (4) Lodge meetings per year.
- Sec. 3. The Lodge shall publish a bulletin to inform the membership of the Lodge of the activities and meetings.
- Sec. 4. Special meetings of the Lodge may be called by the Lodge chief and staff and/or lay advisers.

Sec. 5. All meetings will be governed by Robert's Rules of Order, Revised

Sec. 6. Voting- Adult Scouters, age 21 or older, do not have a vote in matters of Lodge business (Ref Art. 6, Sec. 2).

#### ARTICLE ELEVEN -- FINANCE

Sec. 1. All Lodge funds shall be handled through the council service center and shall be subject to the council's normal accounting and auditing procedures.

Sec. 2. All fees will be established by the Lodge executive committee.

Sec. 3. An annual budget will be adopted and approved by the Lodge executive committee.

#### ARTICLE TWELVE -- AWARDS

Sec. 1. To maintain the proper ratio of youth to adult for any award given by the Lodge, at least half of the recipients must be youth members. In case of only one award in a given category, it must be presented to a youth member.

Sec. 2. Awards of this Lodge shall be:

<u>Kuskitannee Camping Award</u> given annually to Scout troops in the council which best fulfills the requirements set forth by the Lodge executive committee.

<u>Silver Chief Award</u> given annually to two Lodge members, one youth and one adult, who have rendered noteworthy service of exceptional quality to the Lodge. This is the highest award given by the Lodge. The recipients will be selected by the following:

#### Youth Award

Sub. Sec. 1. Youth and adult members alike that have received this award will vote for a youth recipient, however if there are not more youth than adult voting in this category (See next section)

Sub. Sec. 2. If Sub. Sec. 1. is not attainable then all youth and adult members alike that have received this award as well as all other youth members of the Lodge will vote for a youth recipient as to increase the voting ratio.

#### Adult Award

Sub. Sec. 3. All members of the Lodge youth and adult alike will vote for the recipient of the adult award.

<u>Founder's Award</u> is given to one youth and one adult per year. This is a National Award. The selection process will follow current National Policy for selection of candidates for this award. The recipients will be selected by the following:

#### Youth Award

Sub. Sec.4. Youth and adult members alike that have received this award will vote for a youth recipient, however if there are not more youth than adult voting in this category (See next section)

Sub. Sec. 5. If Sub. Sec. 4. is not attainable then all youth and adult members alike that have received this award as well as all other youth members of the Lodge will vote for a youth recipient as to increase the voting ratio.

#### Adult Award

Sub. Sec. 6. All members of the Lodge youth and adult alike will vote for the recipient of the adult award.

Other awards are as determined by the national Order of the Arrow committee or the Lodge executive committee.

#### ARTICLE THIRTEEN -- VETO POWER

Sec. 1. The scout Executive or his designate shall have full veto power in all matters before the Lodge or Lodge executive committee.

#### ARTICLE FOURTEEN -- AMENDMENTS

Sec. 1. These rules and regulations shall be subject to amendment at any regular or special meeting of the Lodge, provided such amendments have been submitted in writing to the Lodge membership at least two weeks prior to the meeting; and said amendments have been previously been approved by the Lodge executive committee and the Scout Executive or his designate.

Sec. 2. A two-thirds vote of those voting members present shall be required to pass an amendment.

Sec. 3. Any Changes in national Order of the Arrow policy shall take effect immediately in this Lodge and will be so provided for in these rules in future printings.
